*** GOLF CARTS ALLOWED WITH PROOF OF CURRENT LIABILITY INSURANCE. BICYCLES, MOPEDS, MOTORCYCLES, GO-CARTS, UNAUTHORIZED PEOPLE MOVERS, ATVS (handicapped excepted), ETC. NOT ALLOWED ON SHOWGROUNDS. STATE PLATED RTV'S, UTV'S, PERSONAL TRANSPORTATION VEHICLES NOT ALLOWED ON SHOWGROUNDS WITHOUT SPECIAL PERMIT. SEE BELOW FOR PERSONAL PEOPLE MOVERS.**

*** RENTAL GOLF CARTS AVAILABLE AT MAIN GATE.**

*** ALL AUTHORIZED PERSONAL TRANSPORTATION UNITS MUST DISPLAY A PERMIT.**

*** PERMITS AVAILABLE AT MAIN SPECTATOR AND NORTH (REGISTRATION) GATES.**

*** REGULAR PERMITS ARE \$20. HANDICAP PERMITS ARE FREE WITH VALID SECRETARY OF STATE PROOF. AUTHORIZED CLUB WORKERS WITH PROOF OF COMMITTEE PERMITS ALSO FREE.**

*** SPEED LIMIT OF 5 MPH ENFORCED.**

*** MUST BE 16 WITH VALID DRIVERS LICENSE TO OPERATE. ALL UNITS MUST BE OPERATED IN A SAFE MANNER. UNITS SHOULD BE PARKED BY DARK EXCEPT IN SPECIAL CIRCUMSTANCES WHICH DO INCLUDE A TRIP TO THE BATH HOUSE. UNITS THAT MUST BE OPERATED AFTER DARK MUST HAVE WORKING HEAD AND TAIL LIGHTS.**

*** DO NOT DRINK AND DRIVE ON OUR SHOWGROUNDS!**

*** FAILURE TO COMPLY WITH ALL RULES WILL RESULT IN YOU BEING ASKED TO LEAVE. UNSAFE OPERATION WILL NOT BE TOLERATED FOR THE SAFETY OF ALL OF US!**

*** ALL CLUB MEMBERS ARE AUTHORIZED AND REQUIRED TO ENFORCE SAFETY RULES.**

PERSONAL PEOPLE MOVERS

*** ALL PERSONAL PEOPLE MOVERS MUST BE INSPECTED PRIOR TO USE AND WILL BE ISSUED A PASS TO BE ON SHOWGROUNDS. DECISIONS OF INSPECTORS AT REGISTRATION GATE ARE FINAL.**

*** MUST BE SAFE TO OPERATE AND RIDE ON DEPENDING ON STYLE OF UNIT. IE - FENDERS, SECURE SEATING, SAFETY RAILINGS, HANDHOLDS, FOOTRESTS WITH HEEL CATCH, ETC. FOR EACH PASSENGER. CAN NOT EXCEED 5 FEET IN WIDTH.**

*** SPEED LIMIT OF 5 MPH ENFORCED.**
