- * NON-MEMBER EXHIBITORS MUST HAVE PROOF OF LIABILITY INSURANCE**
- * REGISTER AT NORTH GATE (see showgrounds map <http://mmogta.org/Showgrounds.html>).**
- * WE DO NOT SHARE YOUR PERSONAL INFORMATION, BUT IT'S IMPORTANT FOR US TO KEEP ACCURATE RECORDS OF OUR VISITORS AND EXHIBITORS.**
- * QUALIFIED EXHIBITORS ISSUED 2 FREE WEEKEND PASSES (WRISTBANDS). ADDITIONAL PEOPLE PAY NORMAL RATES FOR DAY OR WEEKEND PASSES.**
- * EXHIBIT TRANSPORTATION TRAILERS MUST BE PARKED IN TRAILER PARKING AREA.**
- * VEHICLES MUST BE PARKED IN SPECTATOR PARKING OR AT CAMP SITE.**
- * NON-MEMBER EXHIBITORS CAMPING FEE IS \$5.00. ALL OTHER CAMPING RULES APPLY.**
- * OPERATING EXHIBITS ARE ENCOURAGED BUT MUST BE SAFE.**
- * NO UNATTENDED RUNNING TRACTORS OR ENGINES ALLOWED.**
- * NO RIDERS ON TRACTORS WITHOUT FENDERS**
- * MAXIMUM OF 2 PEOPLE ON A TRACTOR**
- * ANYONE OPERATING POWERED EQUIPMENT MUST BE ON THE EQUIPMENT, IN FULL CONTROL AND OPERATE IT IN A SAFE MANNER. SPEED LIMIT OF 5 MPH.**
- * MUST BE MINIMUM OF 13 YEARS OLD TO OPERATE A TRACTOR UNLESS ACCOMPANIED BY AN ADULT.**
- * INTOXICATED PERSONS NOT ALLOWED TO DRIVE, OPERATE OR BE CLOSE TO OPERATING EQUIPMENT AND NO DRINKING AND DRIVING.**
- * NO SMOKING WHILE FUELING.**
- * FIRE PROTECTION EQUIPMENT MUST BE READILY AND QUICKLY AVAILABLE FOR OPERATING EQUIPMENT.**
- * ALL BELTED EQUIPMENT MUST HAVE SAFETY PERIMETER BARRIER.**
- * SHADE CANOPIES ARE FINE IF THEY DON'T INTERFERE WITH TRAFFIC FLOW.**
- * PLEASE KEEP YOUR DISPLAYS SAFE, NEAT, AND CLEAN.**

SMALL ENGINE EXHIBITS

*** SMALL ENGINE EXHIBIT CAMPERS MUST FOLLOW NORMAL CAMPING AND PARKING RULES. SORRY - WE JUST DO NOT HAVE SPACE FOR CAMPING OR PARKING WITH EXHIBITS.**

*** ENGINES MAY BE DISPLAYED ON TRAILERS, BUT TOW VEHICLES MUST BE PARKED IN SPECTATOR PARKING OR CAMPING AREAS.**

*** FIRE PROTECTION EQUIPMENT MUST BE READILY AND QUICKLY AVAILABLE FOR OPERATING EQUIPMENT.**

*** RUNNING ENGINES MUST BE ATTENDED AND SAFE.**
